OFFICE ORDER

In accordance to the inspection report submitted by Inspection Committee, further, approval of the Hon'ble Vice-Chancellor, the temporary affiliation to Bundi Agriculture College, Mohanpura Indergarh for the academic session 2025-26 is here by granted subjected to fulfilment of the conditions & Suggestions made by affiliation committee as enumerated below:

Conditions:

1. College has to submit the compliance report of suggestions made by Inspection Committee at the earliest.
2. Future affiliation will be renewed subject to fulfilling the recommendations/conditions suggested by the inspection committee.
3. The intake capacity i.e., number of students to be admitted in the first year of B.Sc. (Hons.) Agriculture programme shall not exceed 60 and that the affiliation would be restricted to the academic programme only upto level of under graduate education for the academic session 2025-26. The students shall only be admitted through state level entrance exam i.e., JET to be conducted by state Agriculture universities of the Rajasthan.
4. After completion of admission process, a final list of admitted students in B.Sc. (Hons.) Agriculture shall be submitted to this University by the college.

Suggestions:

1. Before starting the inspection process, the college must submit an Action Taken Report (ATR) detailing the steps taken to address the committee's suggestions from the previous year.
2. College administration needs to ensure proper monitoring of the theory and practical classes. Further, ensure to make the classes regular with 100 percent attendance of the students.
3. There is urgent need to make all the laboratories functional in order to exposure to students and quality education. Each laboratory should have laboratory related items only. There is need to upgrade the laboratory with quality charts & required equipment's.
4. Urgent need to appointment qualified teaching and non-teaching staff as per norms to ensure the quality education. The new appointment just before the process of affiliation should be avoided. The staff must be appointed for the longer duration. Technical person of the laboratory must have practical exposure.
5. Need to develop at least 05 EL units as per 6th Deans' committee for student READY within 6 months. Ensure to make it functional.
6. The administration should provide the budget plan for next academic session.
